**MEMBERSHIP CONDITIONS**

Membership entitles the member and co-member or (designated member in accordance with the By-laws) along with any unmarried children under 23 who are residing at home or attending school on a full-time basis to use the facilities of the Club upon payment of family dues and the required fees for the category of membership chosen. Membership shall include the applicants who signed this document and who shall be individually and jointly responsible for payment of all dues, assessments, and other charges related to their membership.

Members shall be bound by all the club "by-laws" and the "rules and regulations" currently in effect and as may be amended from time to time.

Membership is subject to suspension for failure to abide by membership conditions. Member further acknowledges and agrees that all charges, assessments and expenses incurred in connection with this privilege as a Club Member shall be due and payable upon payment terms. A late fee of \$100 per month will be imposed on all member account balances more than 30 days past due. Member also agrees to pay collection fees, court costs and attorney's fees incurred in collecting such sums and said sums shall be due and payable upon demand. Charging and membership privileges will be suspended if Member's account is more than sixty (60) days delinquent. The Club reserves the right to impose charging limits on a member's account if member is delinquent in his payments.

Membership dues are non-refundable and are due for the entire membership year even if the member files for the right to resign pursuant to the terms of the By-laws. Membership privileges are non-transferable.

Member will be responsible for all charges signed for by Member, Member's family or guests and any charges incurred in collecting such sums. All charges shall be due and payable upon demand. Member should notify the Accounting Department immediately of any discrepancies with their account balance. Member should advise the Club Administrative Office of changes in billing address immediately.

Any member who makes use of any of the facilities of Aberdeen Golf & Country Club or service provided by Aberdeen Golf & Country Club, Inc., its affiliates, subsidiaries, parent company and their representatives, directors, officers, employees and agents (collectively, "Aberdeen"), or who engages in any competition, game, or other activity operated, organized, arranged or sponsored by Aberdeen, either on or off the Aberdeen Golf & Country Club premises, shall do so at his own risk. This includes claims or damages that arise or may arise from or through the use of valet, lockers and bag storage facilities at Aberdeen Golf & Country Club and/or the delivery, entrustment or storage of any personal property including, but not limited to, golf clubs and accessories, clothing and jewelry at or on the property operated and owned by Aberdeen.

The club will make available to any prospective member, the most recent audited financial statement for their review upon request.

Member acknowledges that Club facilities, equipment, hours, service, rules, conditions, dues, assessments, and policies of the Club are subject to change and at the discretion of the Board of Directors without prior notice to Member, unless required by the by-laws.
